

## RESOLUTION 1229

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, AMENDING RESOLUTION 1224 APPROVING 2022 LODGING TAX EXPENDITURES

---

**WHEREAS**, Chapter 67.28 of the Revised Code of Washington and Chapter 3.27 of the Gig Harbor Municipal Code authorizes the City to collect an excise tax on lodging, which tax is to be used for tourist promotion; and,

**WHEREAS**, the City Council established a Lodging Tax Advisory Committee in GHMC Chapter 2.53 to make recommendations to the Council for expenditure of the funds; and,

**WHEREAS**, on October 12 and 18, 2021, the Committee adopted its recommendations for 2022; and,

**WHEREAS**, on December 13, 2021, the City Council adopted Resolution 1224 approving 2022 lodging tax expenditures and requested that Lodging Tax Advisory Committee reconsider recommending a \$5,000 grant to the Asia Pacific Cultural Center for the Korean ChuSeok Festival; and,

**WHEREAS**, on December 9, 2021, the Lodging Tax Advisory Committee recommended that the City Council authorize a \$5,000 grant to the Asia Pacific Cultural Center for the Korean ChuSeok Festival; and,

**WHEREAS**, on December 9, 2021, the Lodging Tax Advisory Committee also recommended that the City Council designate the Gig Harbor Chamber of Commerce as the recipient of the \$5,000 grant for the Celtic Music Festival in lieu of Dunagan Brewery;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Gig Harbor:

**Section 1.** The City Council amends Exhibit A of Resolution 1224 to include a \$5,000 grant for the Asia Pacific Cultural Center's Korean ChuSeok Festival and to designate the Gig Harbor Chamber of Commerce as the recipient of the \$5,000 grant for the Celtic Music Festival in lieu of Dunagan Brewery, as set forth in Exhibit A.

**Section 2.** The Mayor is authorized to enter into agreements with the recipients of these revenues up to the amounts authorized by this Resolution.

**Section 3.** This Resolution takes effect on its adoption.
