**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, CERTIFYING THE 2021 REGULAR AD VALOREM TAX LEVY UPON REAL PROPERTY.**

WHEREAS, the City Council of Gig Harbor has met and considered its budget for the calendar year 2021; and

WHEREAS, the City's actual levy amount from the previous year was \$3,007,357.49; and

WHEREAS, the population of the city is more than 10,000; and now, therefore,

THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

The dollar amount of the increase over the actual levy amount from the previous year shall be \$0.00 which is a percentage increase of 0.0000000% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
