1. <u>Utility Extension, Capacity Agreement - Rita Plat.</u> Mark Hoppen, City Administrator, presented this request by Trilogy Development Corporation for 27 ERUs for a plat off Burnham Drive. He described the location and answered questions.

2. <u>Consultant Services Contract - The Shea Group.</u> Mark Hoppen explained that this contract was to allow for a continued relationship with David Skinner to provide continuity on projects such as the Comprehensive Plan and water permit issues, in addition to closure on larger projects such as the East-West Roadway. He addressed Council's concerns on the contract amount and transitioning to a new Public Works Director. He explained that the position had been reposted to broaden the pool of prospective applicants. He introduced David Brereton, who is the Interim Public Works Director, and Steve Misiurak, who is Interim Assistant Public Works Director / City Engineer until the hiring process is complete.

Pat Iolavera, Planning Associate, gave an overview of the issues left to address before the permit could be issued. Councilmember Dick said that he was anxious to see the project completed and asked for an effort to expedite the process.

Councilmember Pasin asked who would be in charge of overseeing the construction of the Gig Harbor Civic Center. Mr. Hoppen explained that there were weekly meetings between the contractor, the Building Official/Fire Marshal, Kim Lyonnais, John Vodopich, Planning Director, and Chris Munter, Public Works Engineer. Councilmember Pasin then asked for an update on the Hearing Examiner contract. Carol Morris said that the contract had been approved and that the new Hearing Examiner was on board.

# A RESOLUTION OF THE CITY OF GIG HARBOR IN SUPPORT OF THE NATIONAL EFFORT TO ERADICATE TERRORISM.

WHEREAS, innocent citizens of our Nation were viciously attacked and killed by terrorists on September 11, 2001; and

WHEREAS, terrorism in our nation seriously damages our citizen's domestic tranquility; and

WHEREAS, terrorism is a threat to our citizens at any point in time; and

WHEREAS, our national leaders have called for resolve and patience as we develop a response to terrorism; and

WHEREAS, our leaders face a formidable adversary who is difficult to identify; and

WHEREAS, we expect this to be a prolonged and sustained campaign that will require sacrifice from our citizens;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

To support our National efforts by standing with our President, our Congress, our diplomats and our military to eradicate terrorism;

To carry out our individual responsibilities in a manner that will encourage National unity and strength;

To honor and celebrate our shared values:

To review our law enforcement and emergency procedures to insure effective local, state and/or national response to any terrorist activities that directly or indirectly threaten our citizens; and

The August activity statistics are attached for your review.

The Reserves volunteered 112 hours in August. Their duties included patrol and court transports.

The Marine Services Unit logged 52 hours of patrol time, 2.5 hours of maintenance time, and 3.5 hour of administrative time. The unit responded to 3 dispatched calls, conducted 14 safety inspections, 5 boater assists, and answered 1 boating complaint. They also went on 1 search and rescue callout.

The bike patrol was active for 13 hours in August.

Officer Garcia has now completed his Field Training program and is working on his own. This brings us back to our full authorized staffing.
