ORDINANCE NO. 675

AN ORDINANCE OF THE CITY OF GIG HARBOR, WASHINGTON, AMENDING ORDINANCE 654 AND 665, RELATING TO THE ESTABLISHMENT OF THE 1994 CITY PERSONNEL SALARY SCHEDULE.
