1. BOGUE VIEWING PLATFORM RFP

DISCUSSION POINTS

In consideration of the current downturn in the economy, Stanton reported that the City Administrator recommended delaying the Request for Proposals for the Bogue Viewing Platform Public Art Placement until the 2nd quarter of 2009. At that time, the decision to move forward will be re-evaluated.

2. BRICK PLANTER AT PIONEER

DISCUSSION POINTS

The final Design for the Brick Planter in front of the old Harbor Inn Restaurant at the intersection of Pioneer and Harborview Drive has been approved. It does not include space or funds for public art.

RECOMMENDATION / ACTION / FOLLOW-UP
