Old Business

1. OUTDOOR GALLERY PROGRAM

DISCUSSION

Pedestal installation scheduled next week. Staff will circulate updated "Call for Artist" information and post to the City website by the end of September. Commission will set Special Meeting in January to review "Call for Artists" submittals.

Artist chosen and will await final Eddon Beach Restoration Project design prior to beginning work on the public art. The conceptual design is expected before the end of the year with work beginning in the spring.

MARITIME PIER PUBLIC ART

DISCUSSION

Commissioner Reese excused herself from the meeting regarding details on the Pier sculpture. Glock-Jackson asked whether the Arts Commission would like to contribute to bronze statue of a man holding a salmon at the Maritime Pier location proposed by David Senner. The Budget for the work was estimated at \$150,000. In response to a concern that the work be realistic, staff clarified that the sculpture was to be a representational work based on the historic photo provided to the artist. Commission recommends that the City request that a "maquette" be provided by the artist. A motion was made by Shaw that Glock-Jackson to prepare and submit a letter to Council regarding the importance of an authentic and realistic representation of the Fishermen's Sculpture at the Maritime Pier location. (Shaw/Woock)

Glock-Jackson will circulate the letter to the Commission and forward to Council.

DISCUSSION

Event Banner hung across Harborview Drive requires that sponsoring organizations provide insurance and liability coverage. Glock-Jackson asked whether the Arts Commission can sponsor this coverage for smaller groups that cannot afford it. Strickland made a motion to request that the city bear the cost since it supports and promotes cultural events for the community. (Strickland/Shaw – unanimous support)
