RESOLUTION NO. 1108

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, DEEMING CERTAIN OUTSTANDING ACCOUNTS RECEIVABLE TO BE IRRECOVERABLE AND ACCORDINGLY ALLOWING SUCH DEBT TO BE REMOVED FROM THE CITY'S FINANCIAL RECORDS.

WHEREAS, the City of Gig Harbor has a list of eleven outstanding accounts receivable, totaling \$1,210.32; and

WHEREAS, the City of Gig Harbor has exhausted all reasonable efforts to collect on these accounts receivable; and

WHEREAS, ten of the eleven outstanding accounts now exceed the statute of limitations for collections; and

WHEREAS, the eleventh outstanding account is deemed uncollectible due to the depletion of grant funding; and

WHEREAS, the *Government Finance Officers' Association* "Best Practices" on revenue control provides that management of accounts receivable should include periodic write-offs to ensure that accounts receivable balances are not overstated; and

WHEREAS, the City of Gig Harbor Finance & Safety Committee has considered and approved the irrecoverable debt write-off through resolution;

NOW, THEREFORE, the City Council of the City of Gig Harbor, Washington, hereby resolves as follows:

Outstanding accounts receivable as set forth in the attached Exhibit "A" and totaling \$1,210.32 are hereby deemed irrecoverable and accordingly may be removed from the City's Accounts Receivable Aging Report and other financial records.
