## **ORDINANCE NO. 1437**

## AN ORDINANCE OF THE CITY OF GIG HARBOR, WASHINGTON, AMENDING THE 2020 GENERAL FUND NONDEPARTMENTAL BUDGET; AMENDING THE 2020 BUDGET FOR THE PARK DEVELOPMENT FUND; AND INCREASING THE SALARY RANGE FOR CITY ATTORNEY

**WHEREAS,** an adjustment to the 2020 annual appropriation of the General fund Non-Departmental budget is necessary to conduct city business; and

**WHEREAS,** an increase to the salary range for City Attorney is necessary to conduct city business; and

**WHEREAS**, an adjustment to the 2020 annual appropriation of the Park Development fund is necessary to conduct city business; and

**WHEREAS,** the City Council expects the general fund actual beginning fund balance to be at least \$400,000 more than is budgeted; and

**WHEREAS,** the City Council desires to amend the budget in order to change the scope of the Ancich Park Float System project; and

WHEREAS, the Ancich Float System project budget will be increased from \$400,000 to \$1,200,000; and

WHEREAS, THE City Council directs that no contracts or work be performed on the Ancich Float System Project until after City Council approval of a financing agreement for no less than \$500,000.00 with the Gig Harbor Canoe and Kayak Club for the project; and

**WHEREAS**, the general fund portion of the increased project budget is increased to \$390,000;

NOW, THEREFORE,

## THE GIG HARBOR CITY COUNCIL ORDAINS AS FOLLOWS:

Section 1. The 2020 Budget shall be amended as follows:

Section 2. The 2020 Salary Ranges shall be amended as follows:

Section 3. The Gig Harbor City Council finds that it is in the best interests of the City to increase appropriations as shown above and directs the Finance Director to amend the budget as shown above.

Section 4. Severability. If any section, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, clause or phrase of this Ordinance.

Section 5. Effective Date. This Ordinance shall take effect and be in full force five (5) days after passage and publication of an approved summary consisting of the title.
